 The Pollution Liability aggregate limit has increased from \$3,000,000 to \$5,000,000, at no additional cost.

The Volunteer Accident limit has increased from \$100,000 to \$200,000.

 The Privacy Breach Expense coverage limit has increased from \$25,000 to \$50,000, at no additional cost.
